RHEA MAE KNAGIN SCHOLARSHIP GUIDELINES & REQUIREMENTS

BACKGROUND

The Rhea Mae Knagin Scholarship is designed to recognize and provide financial support to any student who demonstrates scholastic ability who is seeking a higher education.

NUMBER OF SCHOLARSHIPS

There will be a total of three scholarship awards. One for \$1000.00 to the applicant receiving highest total score and Two for \$500.00 to applicants receiving second and third highest total scores, respectively.

WHO MAY APPLY

Applicants must be a High School graduate or GED equivalent and an enrolled member of the Native Village of Port Lions with a grade point average of 2.5 C+ or higher, and plan to attend a University or Vocational School in the State of Alaska. Previous Recipients of the Rhea Mae Scholarship may reapply.

APPLICATION REQUIREMENTS

1. Completed Application. Answer all questions, do not leave anything blank. If it does not apply to you put N/A. **Incomplete applications will automatically be disqualified.**
2. Short Essay describing who you are and your educational goals.
3. Budget, include other funding sources.
4. Proof of enrollment to the Native Village of Port Lions.
5. Three (3) letter's of reference; one **must** be from a teacher.
6. Most recent high school or college transcripts (Photocopies are accepted).
7. Proof of acceptance or letter from school stating you have applied.
8. Photograph of self with the signed consent form.
9. Students who are re-applying for this scholarship must re-submit all above requirements

SUCCESSFUL APPLICATION RESPONSIBILITIES

1. Recipients of the Rhea Mae Knagin Scholarship are required to submit official transcripts to the Native Village of Port Lions at the end of the school year or course.
2. Recipients of the Rhea Mae Knagin Scholarship must notify the Native Village of Port Lions immediately if you change your mailing address prior to disbursement of scholarship funds.
3. If the recipient(s) fails to attend the university or vocational school specified in his/her application, the Rhea Mae Knagin Scholarship will be forfeited.

4. **In the event the RMK Scholarship is forfeited, immediate reimbursements of funds are to be submitted to the Native Village of Port Lions.**
5. Failure to comply with all successful application responsibilities will make you ineligible for future RMK Scholarships, until applicant becomes compliant.

RMK SCHOLARSHIP AWARD

Checks will be made payable directly to the student.

RMK SCHOLARSHIP DEADLINE

Applications must be turned in to the Native Village of Port Lions Tribal office or postmarked by **June 30th 2011**. Applications turned in to the Tribal office must be submitted prior to 3:30PM.
